#### Procedure

for execution of documents when students fail to fulfil the obligations set forth in the Charter, the Students' Code of Conduct, other local regulations of FSBEI HE NWSMU named after I.I. Mechnikov under the Ministry of Health of the Russian Federation

The procedure for execution of documents when students fail to fulfil the obligations set forth in the Charter, the Students' Code of Conduct, other local regulations of the University regulates the manner of execution of documents when students of the University fail to fulfil the obligations set forth in the Charter, the Students' Code of Conduct, other local regulations of the University and establishes the standard forms of such documents.

- 1. If there are 7 classes missed without a good reason, the dean issues a once-off warning about the possibility of applying disciplinary measures to the student. The student writes a letter of explanation addressed to the dean about the reason for missing classes. Then the assistant dean prepares a written warning to the student about a possible reprimand and, subsequently, a possible expulsion (see standard form in Appendix No. 1). The written warning is signed by the dean. Familiarization of the student with a written warning is mandatory.
- 2. If there are 12 classes missed, a disciplinary sanction in the form of a reprimand is applied to the student. The student writes a letter of explanation addressed to the Rector about the reason for missing classes. The assistant dean prepares a memo on behalf of the dean of the faculty (see standard form in Appendix No. 2). A memo with an attachment of a written warning to the student(s) (if any) shall be agreed with the Head of the Training Center for BSM Programs and the Vice-Rector for Academic Affairs, after which the assistant dean prepares a draft order to reprimand the student(s) (see standard form in Appendix No. 3). Familiarization of the student(s) with the order on the reprimand is mandatory. An extract from the order declaring a reprimand is filed in the student's personal file.
- 3. If there are 17 classes missed, a disciplinary sanction in the form of an expulsion is applied to the student.
