- 4. Certificate of recognition of foreign education (for foreign citizens, stateless persons and persons educated abroad)
- 5. Notarized translation of passport into Russian;
- 6. Medical certificate (086-Y) certified by the University medical office and X-ray data;
- 7. Statement from the employee of the University Department of Visa Support and Migration Registration on the legality of the foreign citizen's stay in the territory of the Russian Federation

How to obtain this Statement, foreign students must provide:

- passport (and passport translation)
- fingerprinting

For those who are located in Russia, they are also required:

- study visa (for visa entry), with a validity period sufficient for the restoration and renewal of the visa;
- migration card, for the purpose of entry "study" (except for citizens of the Republic of Belarus and those with a residence permit, temporary residence permit);
- detachable part of the notification form on the arrival of a foreign citizen in the place of stay with a period of migration registration sufficient for the restoration period.
- valid medical examination forms:
 - "Medical report on the presence (absence) of infectious diseases" of the established standard, according to Appendix 3 to the order of the Ministry of Health of the Russian Federation dated 29.06.2015 No.384 "Medical report on the presence (absence) of drug addiction" of the established sample, according to the annex to the order of the Committee on Health of 02.12.2015 No.559/1-p
 - "Certificate of absence of HIV infection" of a legally regulated sample
- 8. A certificate from the previous place of study stating that the university does not object to the transfer and has no material or other claims against a foreign citizen (for citizens transferring from other universities).
